The Board of Mayes County Commissioners met in a Special meeting with two members present: Darrell Yoder, Vice-Chairman, Melvin Pritchett, Jr., Member, and Rita Littlefield, County Clerk. The initial notice of the meeting was received in writing June 9, 2010, and the agenda for this meeting was posted on the lower floor of the Court House at 5:00 p.m., June 14, 2010. Commissioner Yoder called the meeting to order in compliance with the Open Meeting Law and the following business was done.

The following officers met with the Board to discuss their Estimates of Needs for FY 2010-11: Frank Canteay and Clarene Crittenden, Sheriff's Office, presented a request for \$1,027,580.00 for the Sheriff's office and \$881,000.00 for the Jail; Lisa Melchior, Assessor, presented a request for \$194,522.00 for the Assessor, and \$240,743.50 for Visual Inspection; Lori Parsons, Court Clerk, presented a request of \$429,876.00 which included the addition of eight employees to the General Fund; Michael Rose, OSU Extension Director, presented a request for \$31,052.00; Darrell Yoder, Commissioner, presented a request on behalf of the Emergency Management Director, requesting \$40,000.00; Kelly Brown, Fair Board President, presented a request for \$22,224.46; Jill McCullah, Election Board Secretary, presented a request for \$79,325.24; Demecia Franklin, Treasurer, presented a request for \$212,800.00; Linda Axley, Health Department Administrative Director, presented a request for \$610,000; Commissioner Yoder presented a request for the Commissioners for \$235,376.00, and a request for \$300.00 for Charity; Rita Littlefield, County Clerk, presented the following requests: \$3,500.00 for Excise Board, \$25,961.16 for County Audit, \$12,000.00 for Photo & Recording, \$1,069,247.72 for County Highway, \$640,018.06 for General Fund, \$1,019,219.18 for Fixed Charges, \$35,288.00 for Purchasing, \$712,831.80 for MESTA, and \$235,600.00 for County Clerk. Some of the Officers' requests included a 5% raise for all employees.

Commissioner Martin, Chairman, came into the meeting at approximately 10:45.
