The Board of Mayes County Commissioners met in a Special meeting with all members present: Darrell Yoder, Chairman, Alva Martin and Ryan Ball, Members, and Rita Littlefield, County Clerk. The initial notice of the meeting was received in writing June 13, 2011, and the agenda for this meeting was posted on the lower floor of the Court House at 4:30 p.m., June 14, 2011. Commissioner Yoder called the meeting to order in compliance with the Open Meeting Law and the following business was done.

The following officers met with the Board to discuss their Estimates of Needs for FY 2011-12: Michael Rose, OSU Extension Director, presented a request for \$32,532.00; Frank Cantey and Clarene Crittenden, Sheriff's Office, presented a request for \$1,042,841.00 for the Sheriff's office and reported operating expenses for the jail at approximately \$821,000.00; Lori Parsons, Court Clerk, presented a request of \$197,952.00; Lisa Melchior, Assessor, presented a request for \$192,115.20.00 for the Assessor, and \$256,138.59 for Visual Inspection; Darrell Yoder, Commissioner, presented a request for \$235,376.00 for Commissioners and \$300.00 for Charity; Kelly Brown, Fair Board President, presented a request for \$71,991.44; Jill McCullah, Election Board Secretary, presented a request for \$82,084.56; Demecia Franklin, Treasurer, presented a request for \$174,820.00.00; Rita Littlefield, County Clerk, presented a request for the Health Department in the amount of \$659,000.00; \$3,500.00 for Excise Board, \$28,244.18 for County Audit, \$12,000.00 for Photo & Recording, \$1,086,570.25 for County Highway, \$625,426.06 for General Fund, \$1,019,820.52 for Fixed Charges, \$35,288.00 for Purchasing, and \$229,804.00 for County Clerk. Some of the Officers' requests included a 2% raise for all employees.
