She believes the Elected Officials are not doing their jobs. She also wanted to know whose job it was to police the filing of meeting notices. Commissioner Martin addressed the splitting of P.O.'s and believes it is a problem and will not be signing them until they get with the State Auditor's Office. Ron Coats asked that the Board take in a flash drive that has Commissioner Martin telling Commissioner Ball splitting P.O.'s is prohibited.
