The initial notice of the meeting was received in writing June 7, 2024, and the agenda for this meeting was posted on the lower floor of the Court House at 2:00 p.m. June 18, 2024. Comm. Rural Road Improvement \$3,000,000.00, County Highway \$2,599,985.96, Grand Gateway \$8,000.00; County Commissioners, \$105,266.00; Alva Martin, District 1 and Randy Pierce District 3, \$1,018,448.00 or \$1,324,740.80 with 27% raise; Bobbie Martin, Treasurer \$229,100.00 and if the 27% stands asks for the additional 17% raise; Brittany True-Howard, County Clerk \$520,536.00 includes 3% raise, Photo and Recording \$12,000.00, Purchasing \$72,764.00 includes 3% raise; Withholdings \$4,189,190.31.00 (does not include building and liability); MESTA \$1,437,067.41; Charity \$800.00; Excise Board \$6,000.00; Audit \$122,638.28.
