The Board of Mayes County Commissioners met in a regularly scheduled meeting with all members present: Ryan Ball, Chairman, Meredith Frailey and Kevin Whiteside, Members, Brittany True-Howard, County Clerk. The initial notice of the meeting was received in writing December 15, 2016, and the agenda for this meeting was posted on the lower floor of the Court House at 4:30 p.m., February 2, 2017. Ryan Ball called the meeting to order in compliance with the Open Meeting Law and the following business was done:

PUBLIC COMMENT:

Don Raleigh, was present to discuss agenda item 15. He wanted to let the Board know that the Pryor Schools meet the building requirements and would hate to see the County add additional restrictions that would go above and beyond what the State requires. If they added another level of requirements it would limit what that can provide.

Dr. Mobley was present for the second time to discuss the Oklahoma Universal Building Code. Dr. Mobley would like to ask the Board to make it mandatory to meet the 2015 Building Code standards. The only school that he knows of that meets the FEMA standards is Osage. He has been to Roosevelt and Lincoln and doesn't feel these are adequate storm shelters. Commissioner Ball had concerns about who would inforce it if they put into place. The County does not have Planning and Zoning. If it were put into place and not followed through and someone was hurt where the liability would fall. Commissioner Frailey said her first thought was about all the children killed in Moore and feels it's everyone's responsibility to make sure of their safety, but money always comes into play. She had talked to Mr. Janzen and said there are grants for the schools but many still can't afford the money they have to have up front. ADA Jackie Rhodes concern is realistically what the law requires of the County. Her take is the codes are in place and have to be followed and would caution the board from trying to add provisions to those building codes.
