Commissioner Ball asked Sheriff Reed if he had any thoughts. Sheriff Reed wanted to know why they needed us to join in. Mr. Barron let him know they did not need us but in order for us to receive any money if there is a recovery we would have to be apart of it. There would be a 25% contingency with them upfronting the money. Kevin Dodson didn't have much to add but thought it would be good to see this money go towards things like drug court.

Darrell Moore, Randy Deason and Doug Weaver were present to give an update report on the hospital performance measures and other matters of concern including any potential strategic risks and actions to mitigate those risks. Darrell wanted to thank the Board for last years vote of confidence. He also wanted to let them know that it would be appropriate if one of them wanted to join the conversation with the Hospital Board. Randy wanted to let them know where some of the money went. They were able to finally connect with Hillcrest and they are now adding Doctors. The County tax of about \$75,000.00 which went back to the County. Doug wanted to let the Board know that at some point they will have to do some changes to the building. They want to start looking at in patient care by trying to get funds to upgrade the rooms. They also currently have 8 bays in the ER to take in people and would like to have 16. They want to start moving down the road to quality healthcare.
