Some of the things the County has received are three sirens for the Town of Chouteau, generator grants, and safe room grants. The plan update is around \$100,000.00 and there is a grant for that. The County would have to spend the money up front and then would be reimbursed. They pay 75% the county pays 25% of project. Every time there is a meeting everyone signs in to go against what we owe. We will have to go out for bids for firms but we can't do this until budget time so we can put money in the account first. We will go through a period of time where we won't be able to get grants because of this delay.
