FEMA has gone above and beyond in helping people. Johnny had given them a list of 80 people and they have made contact with over 1,000 from that list. They have gone to different communities to help. They have picked up a dozen people just from being outside the Courthouse. Right now, they are helping with rental, clothing, etc. They will then start to help rebuild. Johnny will have to do substantial estimations on and see if the damage exceeds 50% of the value of the house. He can use the values from the Assessor's Office. If it is substantial, they will have to meet certain requirements to rebuild.
