The thermometers they talked about getting probably won't be here until mid-April. Commissioner Frailey asked Johnny if she thought it would be a good thing to put a shelter in place order in place. Tom said the Governor actually did this for us so we would not need to. Tim Thompson, Under Sheriff said they are trying to handle the essential calls first but they are stretched thin.
